John M. Lundin joined the firm in 2002 and became a partner in 2006. Mr. Lundin's practice focuses on the litigation of large, complex commercial disputes, often with a transnational component. He has represented clients in all aspects of complex commercial litigation, including business disputes involving contract, fraud and intellectual property claims; disputes over the control, ownership and breakup of businesses; disputes involving federal antitrust, racketeering and securities law claims; and representing creditors in bankruptcy proceedings. He is the chair of the City Bar's Committee on Litigation.

Much of Mr. Lundin's work has been for buy-side clients in securities and finance-related disputes and for technology and biotech/pharmaceutical businesses. Although Mr. Lundin most often litigates in the Commercial Divisions of the New York State courts, he has represented clients in state and federal courts throughout the United States, as well as in AAA and FINRA arbitrations.

Dewey Prize for best written brief in the 1996 Harlan Fiske Stone Moot Court Competition and Executive Editor of the Columbia Journal of Law and Social Problems. From 1974 to 1994, Mr. Lundin served in the United States Army as an enlisted person, noncommissioned officer and commissioned officer, retiring with the rank of Major. From 1997 to 1998, Mr. Lundin clerked for the Honorable John T. Noonan, Jr., of the United States Court of Appeals for the Ninth Circuit.
